



## PROPOSED SIDE ELEVATION (WEST) SIDE 1

The engineer shall be notified of any discrepancies prior to construction.</li> <li>6. structural details are subject to exposure of existing construction and verification by Local Authority Surveyor (LAS) and any necessary revised details are to be agreed with the LAS prior to carrying out the affected works.</li> <li>7. All materials are to be used accordance with the manufacturers' guidelines and all relevant British Standards Codes of Practice &amp; Regulation 7 of Building Regs.</li> <li>8. All works are to be carried out in accordance with Local Authority requirements.</li> <li>9. The intended works fall within the Party Wall Act 1996 and any adjoining owners affected must be notified prior to commencement of any works.</li> <li>10.
