Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

The tree is a Sycamore which is situated on the boundary of 22 Highfield Road, Northwood, HA6 1EY and Silver Court 32-24 Rickmansworth Road, Northwood. On the Hillingdon TPO map it is No. 443. The tree is heavily covered in ivy and its branches overhang the garden of 22 Highfield Road. I'm seeking permission to cut back these overhanging branches to the boundary line which would entail lopping 1/1.5 metres off the overhanging branches. This work would be carried out by Fern Leaf Tree Care, Professional Arborists. I have spoken to a representative of Silver Court and they have no objections, in fact they welcome the idea.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
