Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

English Oak. T1 - Fell/Remove - The tree is in a poor health state with hardly any life left in it. The tree is located in between 2 much larger and healthier trees and its only going to get worse.

Hornbeam. T2 - Fell/Remove - The tree has a very low union (co-dominant stems) indicate a weak branch union, these can be structurally weak and have a higher risk of failure (there's another better suitable tree to be kept about 3 metres away of the same species) and the removal will allow for a better use of the garden space.

Hornbeam. T3 - Fell/Remove - The tree was damaged by wind and has already lost part of its crown. We believe that the state that the tree is at present isn't great and will only get worse.

English Oak. T4 - Fell/Remove - The tree is a mature Oak, probably around 50 years old, its in a very poor health state with most of its crown already dead (there's only 3 branches left with any life remaining) which indicates that the tree has some sort of disease and it won't last long but considering its size keeping it would be a hazard.

Silver Birch. T5 - Fell/Remove - The tree has grown very tall but its very skinny as it had so many other much larger trees around it and now it is leaning heavily to one side.

Hornbeam. T6 and T7 - Fell/Remove - Both trees are in very close proximity to each other as well as trying to grow under two very big mature Oak trees. The two crowns under the other two bigger oak trees create so much density and block all the light.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

Sketch plan requirements

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
 - mark and name surrounding roads
 - sketch in buildings, including adjoining properties
 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
