I consider the existing use of land as lawful for which a Certificate of Lawfulness is kindly sought.

The residential property known as 8 Lodge Close, Uxbridge, UB8 2ES, is a small 4-bedroom house in multiple occupation falling within Use Class C4. The property is used as shared rented accommodation by unrelated occupiers, with individual rooms occupied separately with shared use of communal facilities including the kitchen, bathroom/WC. The existing HMO use relates to the residential accommodation within the property and has continued as an established shared-house use for in excess of 10 years.

This property was inspected by Hillingdon Council on the 12th December 2008, who indicated that they were satisfied with it meeting the requirements of an HMO & it has ever since this date continued without interruption as a small HMO rented to 4 unrelated students each consecutive year.

The Certificate of Lawfulness should be granted on the basis that the property has been in continuous use as a small House in Multiple Occupation within Use Class 4 for the relevant lawful period.

The submitted evidence demonstrates a longstanding pattern of occupation by unrelated occupiers living within the property as separate households, with shared use of facilities including the kitchen, bathrooms/WC facilities and other communal parts of the dwelling. The use has therefore been materially distinct from occupation by a single household and has retained the character of a small HMO/shared rented house during the relevant period of time.

The property has continued to be rented out, managed and occupied as shared rented accommodation throughout the relevant period. There is no evidence that the HMO use has been abandoned, nor that the property has reverted to occupation by a single household or undergone any intervening material change of use.

The submitted tenancy evidence and supporting declaration evidence demonstrate that the existing C4 HMO use has continued for the required period. The development is therefore lawful through the passage of time, and a Certificate of Lawfulness should be issued.
