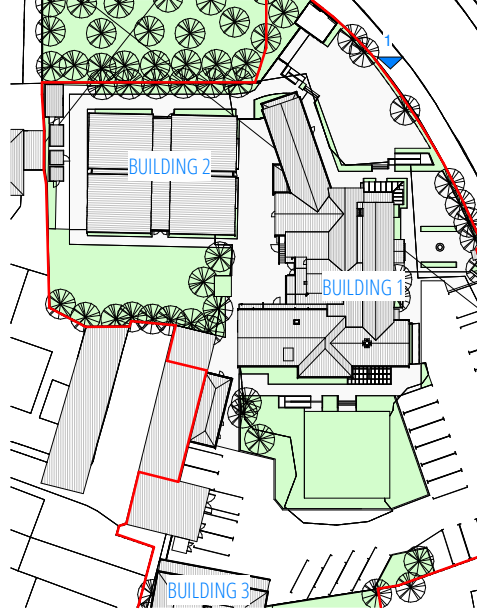


01 PROPOSED REAR / NORTH ELEVATION
