Dear Patricia & John

We write following our recent conversation and site visit made to the above property regarding movement to the existing structure.

The site consists of the original two-storey residential building with a single-storey side extension constructed approximately 13 years ago. Information provided shows that the side extension has been constructed using a pile and ground beam solution. The original building was constructed on concrete strip foundations. There is a large Atlantic Cedar tree approximately 5m to the side of the side extension. A search of Hillingdon Council mapping shows that the tree falls within TPO 7 and is listed as T131.

It was observed on site that there has been substantial movement between the original building and the side extension. This movement has generated a large separation externally and extensive cracking internally. It was mentioned anecdotally on site that the extent of the cracking has gradually increased over time and should therefore be considered ongoing.

Following a review of the ground conditions using data from the British Geological Survey, London Clay is noted as being the likely bearing strata. Chapter 4.2 of the NHBC Standards lists Cedar trees as moderate water demand coniferous. Given the proximity of the Atlantic Cedar to the house, the ongoing movement is highly likely to be as a result of subsidence caused by the heave/shrinkage of the ground generated by the tree.

It is our recommendation that the tree be removed to stop the ongoing movement of the existing buildings. A period of 12-18 months should be left following removal of the tree to allow the ground to stabilize before making the necessary repairs to the affected building.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
