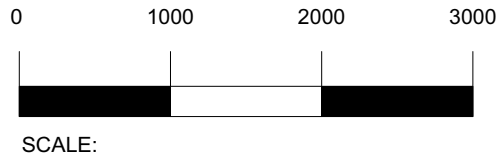

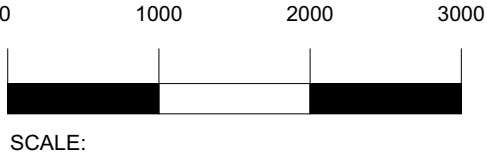

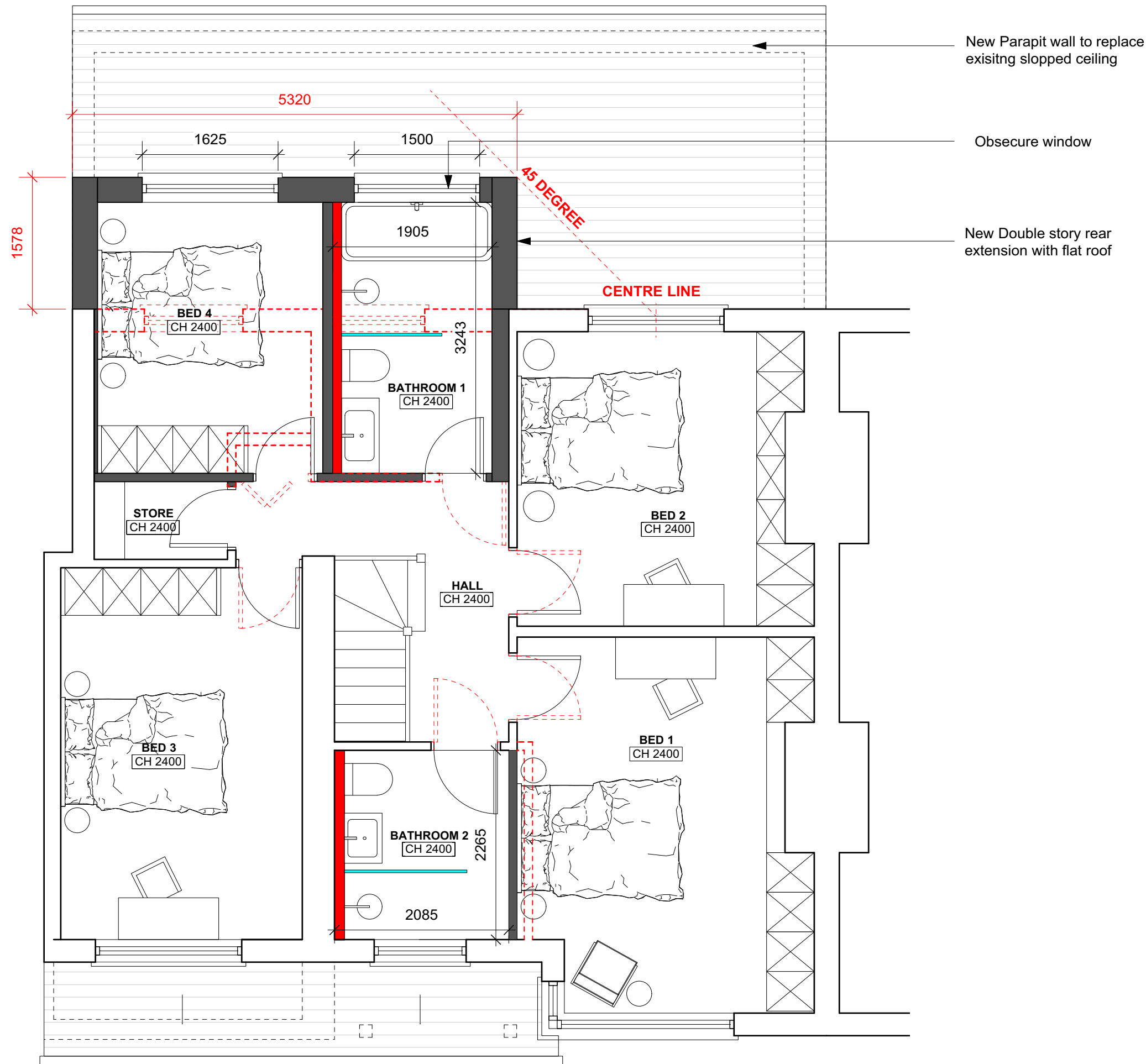

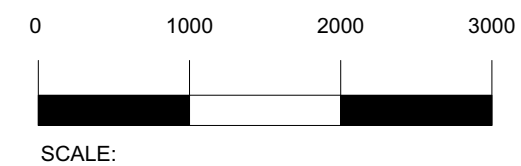

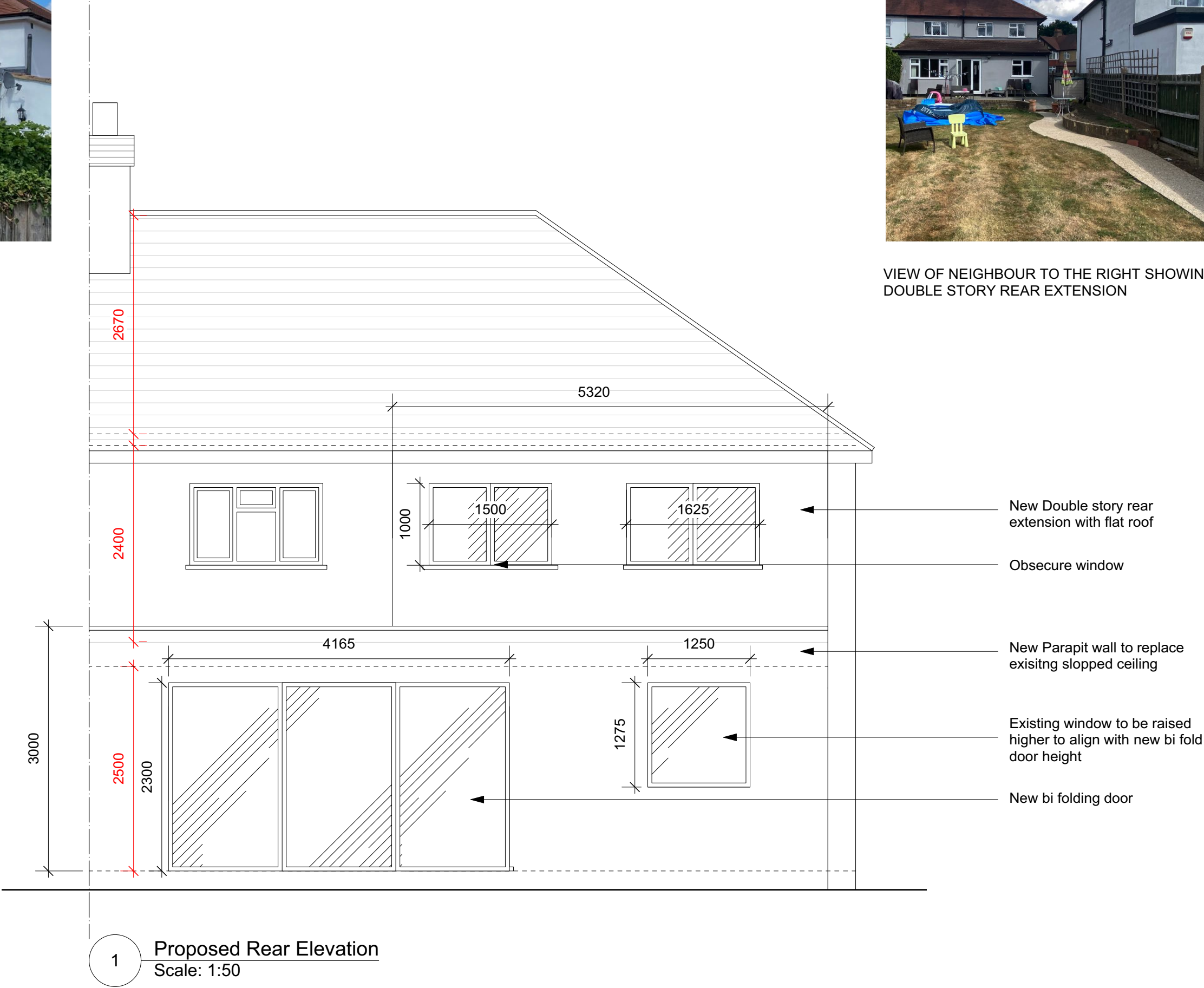




VIEW OF NEIGHBOUR TO THE LEFT SHOWING

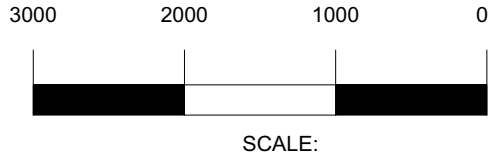
