Cavity partition buildup, with RW3 insulation in between and 2 layers of 15mm sound plasterboard to each side will be used between the shop and proposed dwelling to achieve the required noise 52dBA or more.

Roof will have false ceiling with RW3 insulation in between to achieve the 52dBA or more.

The noise report and assessment will be provided and secured as part of the planning conditions to achieve the council requirement.
