There is no proposed work to do as the work had been completed already.

Initially we had put an application for a Lawful development which was approved back in August 2022. This is the reference for it 49338/APP/2021/1972

. When we were building the Outbuilding, Mitra Davami was instructed by the council to come view the Outbuilding before it is completed. She herself advised that if we put in a kitchen into the Outbuilding, we will have to pay council tax, and someone will be allowed to live in there.

She even said that if our parents live in there, then we will only have to pay a discounted rate of council tax. We did ask in the initial meeting whether we need to do anything else, and she clearly said no, we only need to apply for the council tax. Thereafter, Mitra came again in early May 2022 to view the property once completed and took photos. She took a copy of the contract assigned to the tenants and said that Council Tax will be issued, which Mitra issued for us. This to us confirms what was discussed, and therefore the council tax issued, revived by us in July and paid in full. The letter clearly addresses the council tax for Annex of 10 Roseville Road. Therefore, I request for our case to be put forward to the highest figure at Hillingdon Council and request for the Outbuilding to be granted for self-contained accommodation. Recently we were contacted by Nicholas saying that our initial application does not match with what we have build as we have a sink and hob, therefore we are putting in a new application in. I will attach the complete email thread on this matter for you to review.
