Thank you for your e-mail.

The chances of achieving a 3m second generation extension will be significantly enhanced once the significant extension works at 117 are under way:-

There is no corresponding B/Regs for the works so I am assuming they are not being constructed.

I would suggest getting the application in and seeing how it goes. It will take a detailed assessment on site and impact on 117 may well be an issue (though it appears to have a garage adjacent to 115).
