The rear dormer conforms with the requirement of class B of householders' permitted development rights. It does not exceed the volume of 40m3 (even when considered together with the previously approved increase in the volume of the roof under 49880/APP/2022/2920), The dormer does not project above the ridge height and the distance from the eaves is well in excess of 0,2m.
