The proposal is to fell the tree immediately behind the house at 37 St Martins approach and identified on the submitted plans as T006. The reason for felling is advanced deterioration of the tree as evidenced by the submitted report

  - marking all trees on the plan, but only numbering those to which you want to carry out work
  - showing the approximate distance between the application tree(s) and buildings
  - adding other relevant features on the site (e.g. greenhouse, paths)
