The application is for a family home, class C3. The proposed development will maintain the property as a family home. This development has been designed within the Permitted Development Rights of a semi-detached property. This loft development has been designed within the 50m³ allowance for a semi-detached property. The dormer elevation would be set in by at least 200mm from the existing rear eaves line. The rear extension would be limited to 3m in height and 3m in depth. This scheme has been designed in accordance with the General Permitted Development Order (GPDO). Therefore, the proposal would be lawful.
