Details of the pre-application advice received

- 1F side extension to be set back from front elevation by a minimum of 1m & brick façade
- Roof of the side extension is to be pitched with a width reduced to fit in with the existing building. The proposed ridge to 500mm lower than the existing ridge.
- Rear 1F extension depth of 2m is acceptable, subject to further review.
- Rear 1F extension width to be reduced and set away from the boundary of 2A Belmont rd. A total reduction of 1.5m is acceptable, subject to further review.
- Rear extension windows with opaque bottom sections are acceptable, subject to further review.
- Rear extension pitch roof with opaque rooflight is acceptable.
