Since obtaining planning permission to develop this private residence, our structural engineer and our builder have advised that a demolish and rebuild would result in a structurally sounder and more energy efficient building, as well as a safer and faster build process. Further to this, we note that the property has been vacant for three years and is therefore in a serious state of disrepair. We are submitting this application to obtain permission to demolish and rebuild. The proposed massing of the building and its design, access and heritage considerations all remain the same as in our approved split planning applications 50632/APP/2023/2293 and 50632/APP/2023/2313.
