The property is behind 98 Drayton Gardens, and consists of a garden space and an old garage. Access is via a separate locked gate from Drayton Gardens that goes to the rear of the properties.

The garden is full of weeds and it grows extremely fast.

I would like to clear the space including the garage and reduce the garden size to approximately 16 x 16 (width of the property), and put a new 2 storey building on the remainder of the plot, with a ground floor consisting of a single garage (with electric point, cloakroom, bin space, kitchen cum living cum dining, and stairs to a first floor that will have 2 double bedrooms and a common bathroom.

Since it is facing all the neighbours gardens, the intent is to create a building that is non-descript with no windows on the first floor. The external material will probably be vertical planks of naturally weathered wood (same as the garden fencing), although one could have charred black wood or paint it dark green, or even consider having a mirror finish (although it may be too expensive). In order to reduce the height of the building the minimum ceiling height will be used for the 2 stories (I believe that is 2.3 metres for 85% of the rooms).

Since there is no pre-application consultation facility this application in the first instance is to receive feedback and guidance from your review so that I can achieve the final objective (a modest 2 bed accomodation with parking and garden).

Once it is clear on how to proceed then I can engage professionals to prepare a final proposal.

The property is back to back to the rear garden of 98 Drayton Gardens, and consists of a garden space, an old garage and disused greenhouse. The total plot area is approx. 4.9/5.0 m wide by 13.5 m long. Access is via a separate locked gate from between 102 and 104 Drayton Gardens that goes to the rear of the properties.

The garden is full of weeds and it grows extremely fast, the garage is too basic and the greenhouse is all broken. Apart from the eyesore, our neighbour understandably gets worried every time the garden overgrows and spills over.

1) Change of use to residence

2) Build a house.

In order to utilise the space better I would like to clear the garden and the garage and reduce the garden size to approximately 16 x 16 (width of the property), and put a new 2 storey building on the remainder of the plot, with a ground floor consisting of a single garage (with electric charging point, cloakroom, bin space, kitchen cum living cum dining, and stairs to a first floor that will have 2 double bedrooms and a common bathroom. There will be an 8 foot garden fence around the garden to ensure privacy for the neighbours.

Since it is facing all the neighbours gardens, the intent is to create a building that is non-descript with no windows on the first floor. The external material will probably be vertical planks of naturally weathered wood (same as the garden fencing), although one could have charred black wood or paint it dark green, or even consider having a mirror finish (although it may be too expensive). In order to reduce the height of the building the minimum ceiling height will be used for the 2 stories (I believe that is 2.3 metres for 85% of the rooms per storey).

Since there is no pre-application consultation facility this application in the first instance is to receive feedback and guidance from your review so that I can achieve the final objective (ie a modest 2 bed accommodation with parking and garden). I have tried to keep the footprint to the minimum without making it feel cramped, but if you wish to have it smaller then we can review and consider removing the car parking space, although I would rather keep it.

Once it is clear on the way to proceed then I can engage professionals to prepare a suitable and final proposal.
