I, personally, don't have any objections to the proposed roof alterations (changing the angles of the roof and creating the crown roof) as, to my mind, it will be more in character than the roof alteration considered acceptable by the Inspector on application 5235/APP/2021/1541 which involved raising the wall plates and installing a side dormer.

The crown roof keeps the bulk and mass of the roof design to acceptable proportions and whilst it is an Area of Special Local Character the variety in the street scene is it's greatest asset.
