T25 - Lime - Fell by sectional dismantle and stump grind.
T30 - Lime - Opposite No.42. Pollard removing up to 6-8m.
T33 - Lime - Outside No.38. Monolith to 5m.
T37 - Lime - Opposite Felden. Remove dead wood. Remove epicormics from base of tree and inspect for defects
G43 - Pine - Opposite No.24A. Remove Ivy to 2-3m up up stem and inspect for defects.

Trees I don't believe are covered by TPOs but please check

T3 - Lime - Outside No.57. Fell by sectional dismantle and stump grind.
T7 - Lime - Junction of College Way - Epicormics growth, Ganoderma noted at base, Vertical cavity on roadside - Remove epicormic from base of tree, Inspect and Re-Pollard removing up to 5m
T18 - Lime - Junction of College Way - Epicormics growth, Ganoderma noted at base, Vertical cavity on roadside - Fell by sectional dismantle and stump grind.
T19 - Lime - Outside No.47. Re-pollard to previous pruning points.
T42 - Lime - Appears to be within No.17 Dene Road. Fell by sectional dismantle.
T44 - Lime - Opposite No.22A. Remove dead wood. Remove epicormics from base of tree and inspect for defects.
T45 - Lime - Opposite No.22. Remove dead wood. Remove epicormics from base of tree and inspect for defects.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
