It very much looks as though the ground floor element has been constructed in compliance with the approved ground floor of PP 52688A/99/10 (Erection of a two-storey side and single storey rear extension). You would need to double check the dimensions on the plans and what has been built all tie in.

Subject to that it looks as though planning permission 52668A/99/10 can be completed.
