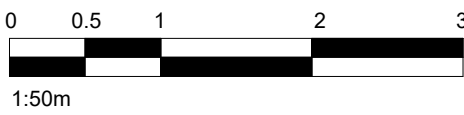
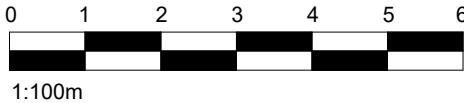
2 Location Plan

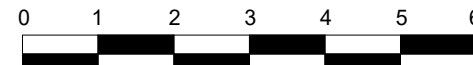


2 Site Plan - Proposed

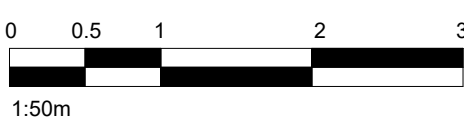
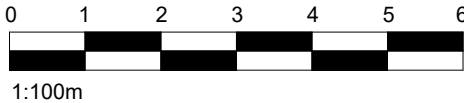


2 Roof Plan - Existing
