Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

The large Oak Tree TPO507 is in need of pruning. It has not been reduced in size in many years and is now so large that there is an increasing danger, particularly when in full leaf in the summer, of another large limb falling down. Five years ago, in May of 2019, an enormous branch broke away which, whilst potentially harmful to my children playing in the garden, was definitely harmful to the tree itself. I am therefore requesting permission to reduce the crown and thin the canopy to make the tree safer by reducing the risk of strong winds causing further damage. I understand that I will have to bear the expense of engaging a suitably qualified/certified tree surgeon to carry out this work should permission be granted.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
