Identification of Tree(s) and Description of Works

Front Garden:

T1 - Oak tree - Raise the crown to give clearance from ground level of approx 5m. This will stop the branches from hitting large parking vehicles. Cut back from neighbours house to give clearance of 2m. Crown thin by 15%

T2 - Large Oak. Crown thin by 20% by removing selected internal crown branches of no more than 3" in diameter to allow greater light through the crown. Cut back from house removing selected limbs of no more than 3" in diameter to create a more fluted upright shape on the house side only and allowing for more than a 2m distance from the house. Remove epicormic growth from the stem.

** T2 is a large Oak tree in close proximity to the house and creating excessive shade to the front windows.. Though there is no "Law for Light" this trees lateral spread has become uncomfortably close to the house and rather than reducing the spread to form possible stubs that will need to be pruned constantly to maintain a desired cut back, the consideration to remove secondary branches growing towards the house should create a more long term impact and therefore less costly to maintain. This would change the shape of the tree from the house side, though it would be done sympathetically but wouldn't affect the over all aesthetics of the tree from the road side.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
 - mark and name surrounding roads
 - sketch in buildings, including adjoining properties
 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
