Description of Proposed Works

Please describe the proposed works

Installation of a Samsung 16kWh heat pump by Econic Energy in front of the house under the Boiler Upgrade Scheme.

As property is just within the cusp of Northwood conservation area and the heat pump cannot be installed in the rear garden owing to distance, access and costs, we understand planning approval is required as it does not meet all the criteria under permitted development.

Heat pump will be positioned behind (and below) the front hedge and are thus not visible from the road seen straight ahead. Additional landscaping and hedging on the side will take place after installation. A wooden box with vents will be built around the heat pump, as shown in the appendix.

The heat pump is a Samsung AE160CXY, a modern efficient heat pump with a very low sound profile, 51 decibel under normal operation and 35 decibels under quiet mode. Heat pump dimensions are 1.27m (width) x 1.0m (height) x 0.5m (depth) with the wooden box having dimensions of 1.5m (width) x 1.1m (height) x 0.65m (depth). The front hedge is currently approximately 2.0m and filling out.
