## Identification of Tree(s) and Description of Works

Tree number - T1/2/3/4/5/6

Tree type - Oak

Approx Height - 16m

Location - Rear garden centre

Service - Crown Reduction

Work required- Crown reduce by removing approximately 2-3m from all over pruning to suitable growth points. Remove major deadwood over 50mm or 1m in length.

Reason - To allow more light into property - client would like you to add a comment in the application highlighting that we have had subsidence, which needed remedial underpinning, because of the proximity of the large trees 2, 3 and 4 to the house. I have added a copy of the report to the application.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

  - mark and name surrounding roads
  - sketch in buildings, including adjoining properties
  - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - marking all trees on the plan, but only numbering those to which you want to carry out work
  - showing the approximate distance between the application tree(s) and buildings
  - adding other relevant features on the site (e.g. greenhouse, paths)
