This application is in relation to the rear outbuilding only. Building works commenced in March 2020 and were complete by July 2020. My client had initially installed a kitchen into this room to provide cooking and sleeping accommodation for private use whilst major renovations and building works were being undertaken to the main dwelling (see various granted planning applications, site number 55695).

In November 2023, Planning Enforcement contacted my Client and requested that the kitchenette area be removed. As you can see from the attached email correspondence and photographic evidence contained within those emails, the kitchenette was removed in its entirety. Confirmation that Planning Enforcement action was closed on the 16th November 2023 also attached.

The dimensions of the outbuilding are 15.3m across the front elevation, by 4.8m deep. The flat roof sits at 2.5m height from external ground level. The room is ancillary to the main dwelling and mainly used for storage, gym equipment and a small private office space. There are cooking facilities or sleeping accommodation provided within this building.

It was never the intention for the building to be for any other use than private and ancillary use to the main dwelling house. The use of the kitchen and habitable area were only a temporary means to provide a little more comfort during the renovation works to the main dwelling.

Planning Enforcement have reviewed this case. Once the kitchen had been removed, no further action was taken against the building itself. We believe as the building has been substantially completed for more than 4 years (July 2020) without complaint or action taken against my client, the outbuilding should now be considered a lawful development.
