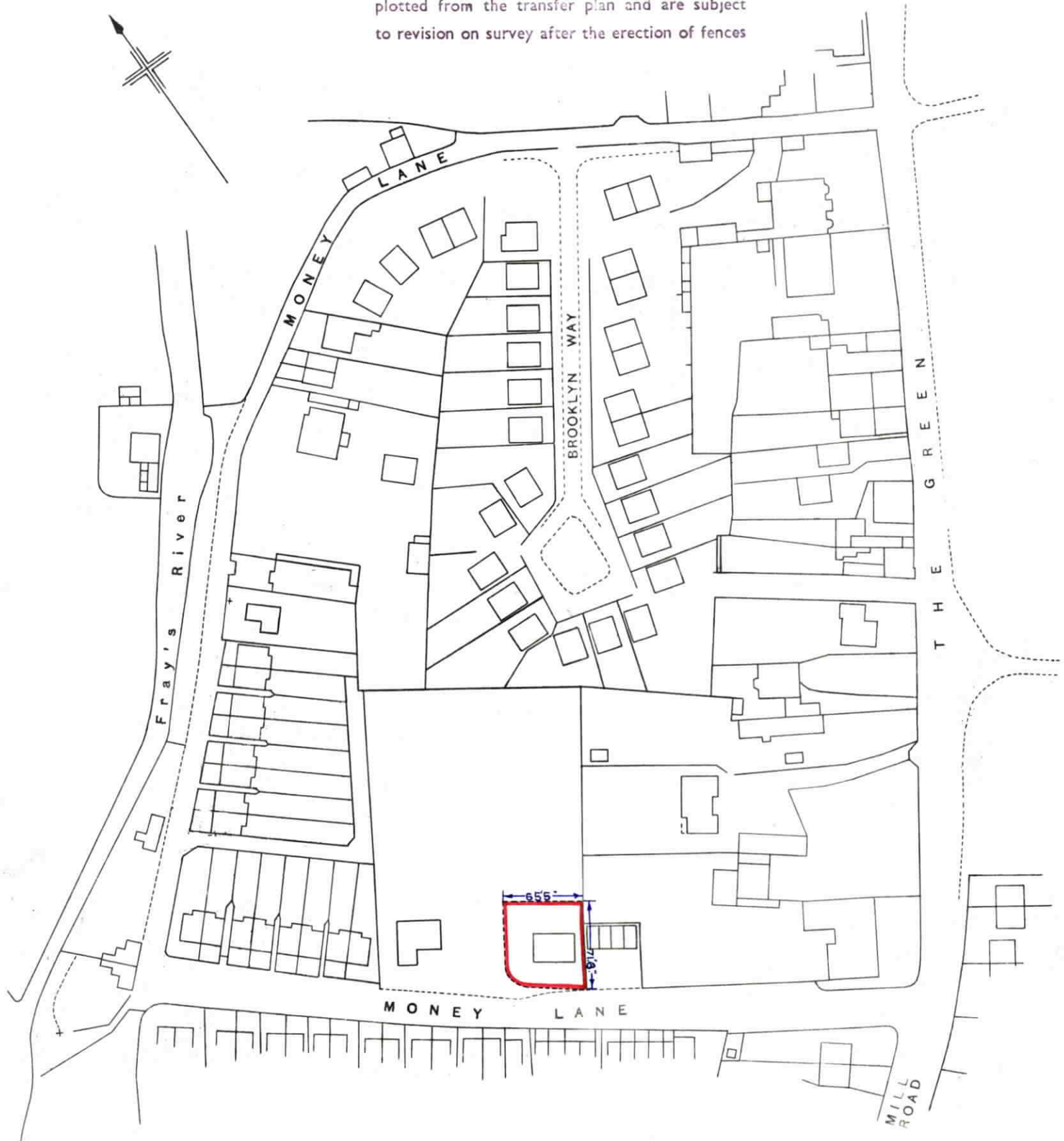

## A: Property Register

This register describes the land and estate comprised in the title.

HILLINGDON

1 (21.06.1961) The Freehold land shown edged with red on the plan of the above Title filed at the Registry and being 14 Money Lane, West Drayton (UB7 7NU).

2 The land has the benefit of the following rights granted by a Transfer dated 28 August 1961 made between (1) Meadlines Property Company Limited and (2) Roy Blumire and Joan Margaret Blumire:-

"(a) The right for the Purchaser and his successors in title in common with others having the like right to the free passage and running of water soil electricity and gas through any existing and future channels drains wires and pipes serving the property hereby transferred and other property now or formerly comprised in Title Number MX428040

(b) A right of way for the Purchaser and his successors in title the owners or occupiers of the property hereby transferred and their undertenants and servants in common with the Vendor and all other persons who have or may hereafter have the like right to pass and repass over and along all roads and footways now or hereafter constructed on the Vendor's said estate to give access to the property from the nearest public highway".

NOTE: The land comprised in Title MX428040 referred to adjoins the north-west, north-east and south-west boundaries of the land in this title.

3 The Transfer dated 28 August 1961 referred to above contains the following provision:-

"The Purchaser and the persons deriving title under him shall not be entitled to any right of light air or otherwise which would restrict or interfere with the free use by the Vendor and the persons deriving title under it of its adjoining or neighbouring property for buildings or other purposes"

## B: Proprietorship Register
