Details of the pre-application advice received

The 4m depth of the single-storey, rear extension would accord with Policy DMHD 1 guidance for detached houses with a plot with of 5 metres or more. Along with the conversion of the integral garage to a bedroom and a bathroom, it could be supported by the Council. The use of matching materials would be required.

However, to accord with Policy DMHD 1 guidance for rear extensions in Conservation Areas, the flat roofed, single-storey extension should be finished with a parapet and the roof lights should be 'conservation style' roof lights that would be flush with the roof.
