Identification of Tree(s) and Description of Works

Dear Hillingdon Council, I hope this email finds you well. I am writing to request permission to reduce a tree on my property. The tree, located at 30 Clovelly Close, HA5 2BP, has grown to the extent that it is now causing issues with the guttering and has resulted in damage to my car. Additionally, the tree's branches have extended beyond acceptable limits, causing concerns for its proximity to my home. I understand the importance of trees and their contribution to the environment and local aesthetics. However, the current situation with this tree necessitates some action to mitigate the issues it is causing. I would like to emphasise that I am not seeking to remove the tree entirely, but rather to reduce its size to a more manageable level that will ensure the tree's health and well-being while addressing the concerns it has created. The specific issues I am experiencing include: Guttering Blockage: The tree's branches have grown to a point where they frequently block the guttering on my property, leading to water overflow during heavy rainfall. This can potentially cause damage to my home's exterior and foundation. Damage to Car: Falling branches and leaves have resulted in damage to my car, which is parked in close proximity to the tree. Overreaching Home: The tree's branches have extended well beyond the property line, causing concerns about potential damage to the roof and structure of my home during adverse weather conditions. Dead wood: Is also visible & with children playing around there its a health and safety concern... plus with high winds this could be a hazard I would like to propose that I would seek a qualified arborist be hired to assess the tree and provide recommendations for reducing its size while ensuring its continued health and stability. I would of course be taking the financial part of this on.. I am committed to ensuring that the tree remains an asset to the neighbourhood while addressing the issues it has created. Please let me know if there is an official process I need to follow in making this request or any other information required from my end to move this request forward. I am willing to comply with all necessary regulations and requirements set forth by the council. I kindly request your prompt attention to this matter, as I believe addressing the tree's overgrowth will help maintain the aesthetic appeal of the area while preserving my property and those nearby. Thank you for your understanding and cooperation. I look forward to your response. Sincerely, Krishna Patel

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
