The building is basically a shell internally but some new stud walls were erected by the previous owner. These are to be removed by the applicant and new stud walls installed in the positions shown on the submitted drawings, if consent is granted.

Externally, it is proposed to create a larger opening at the northern end on the eastern side so that a set of double doors can be installed with adjacent glazed side panels with the glazing matching the style of the other windows. Also, a door on the east side and to the middle of the building will remain but is proposed to be boarded over internally.
