The original brickwork has been cleaned of the paint that had been applied all over the front of the building and pointing restored and the original brickwork restored so the brick finish is considered to be for nicer than applying lime wash to the building.

Rainwater goods. Difficult to get hold of cast iron rainwater goods of the right size so the proposal is to use die cast aluminium rainwater goods which will be finished in a black painted finish.
