Omissions from the approved plans that have not been built are the following:

- Omission of proposed swale to the west of the site.
- Omission of proposed land drain extension adjacent to clay cap in the middle of the site.
- Omission of proposed land drains around air shafts X1 and X2.
- Omission of proposed land drain to the north of the entrance structure into the bunker.
- Omission of proposed works around memorial including relocation of standpipe, regrading falls, relaying of memorial, removal of timber fence.
- Omission of proposed attenuation tank and connecting drainage to S-E corner.
- Omission of proposed tarmac hump and lowering of curb.
- Omission of proposed regrading of earth bund and infilling of basin.
- Omission of proposed internal gutters and associated sumps in plant rooms around air shafts.
- Omission of works to air raid shelter.

Revisions made to the built scheme from the approved plans are:

- Proposed land drain relocated to other side of air shafts Y1 and Y2. The excavation around this area previously formed part of the archaeologists watching brief for excavation works around the air shafts.

Additions to the approved plans built in the final scheme are:

- New pond riser drain to east of the site. Note that this was agreed via email confirmation received from Emilie Bateman Fri 22/09/2023 11:23 confirming this was considered permitted development under Schedule 2, Part 12, Class A (B).
