



<p>GENERAL NOTES</p> <p>All dimensions, levels, sizes, positions and locations of particular as indicated on drawings are to be verified by the appointed Contractor on site prior to engaging in works.</p> <p>Any discrepancies must be reported to the Architect/Structural Engineer or responsible persons immediately.</p> <p>No dimension to be scaled from the drawings for construction purposes unless otherwise indicated. All work is to comply with current Building Regulations.</p>		<p>Party Wall etc 1996 would apply and contractor is to ensure that no work is commenced until this formality is completed.</p> <p>The sole purpose of this drawing is the procurement of Planning Permission and Building Regulation approval and work is NOT to commence before such approvals.</p> <p>Where this drawing is used for the works, contractor should request all the details of the work from the Engineer.
