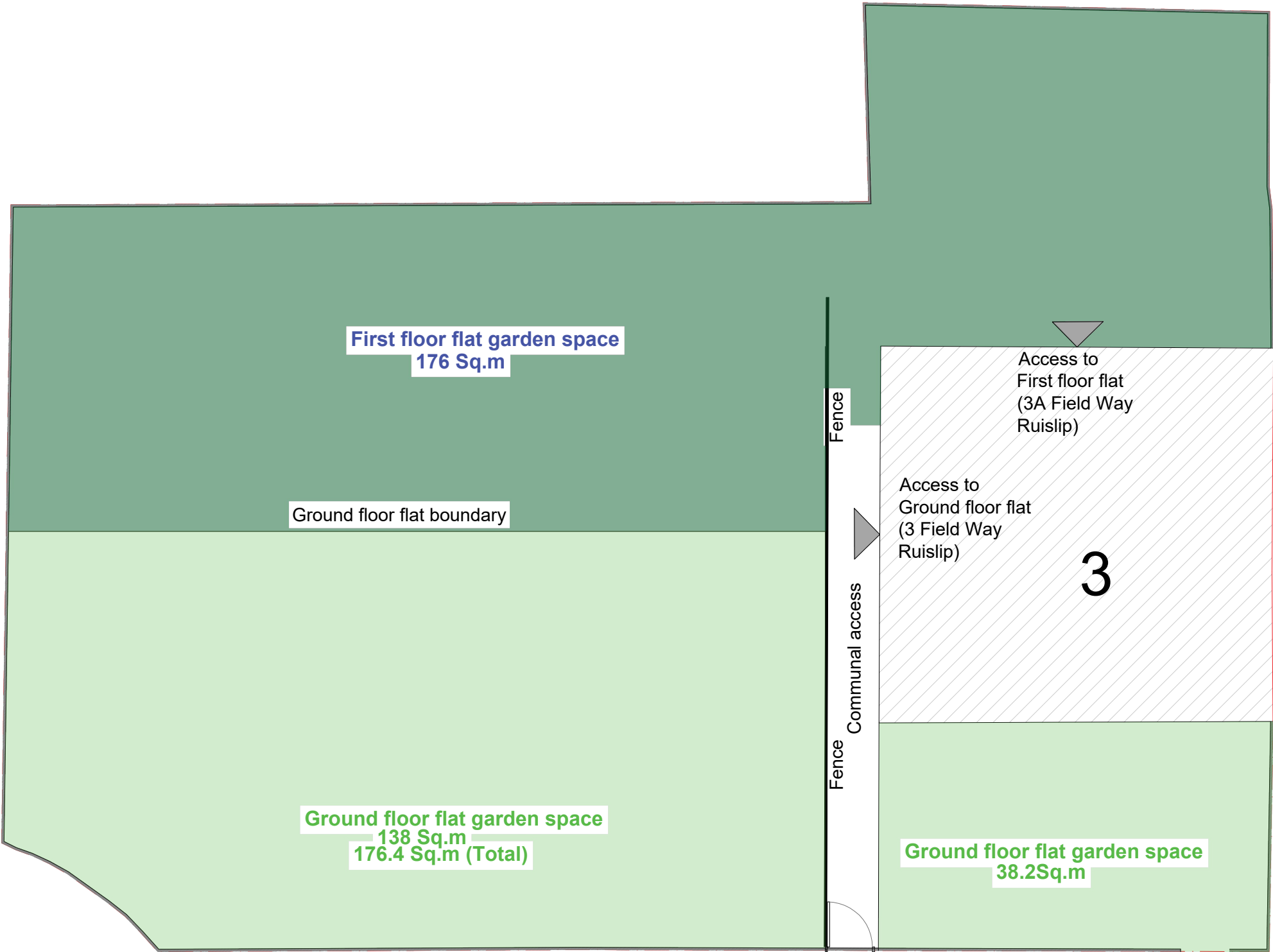

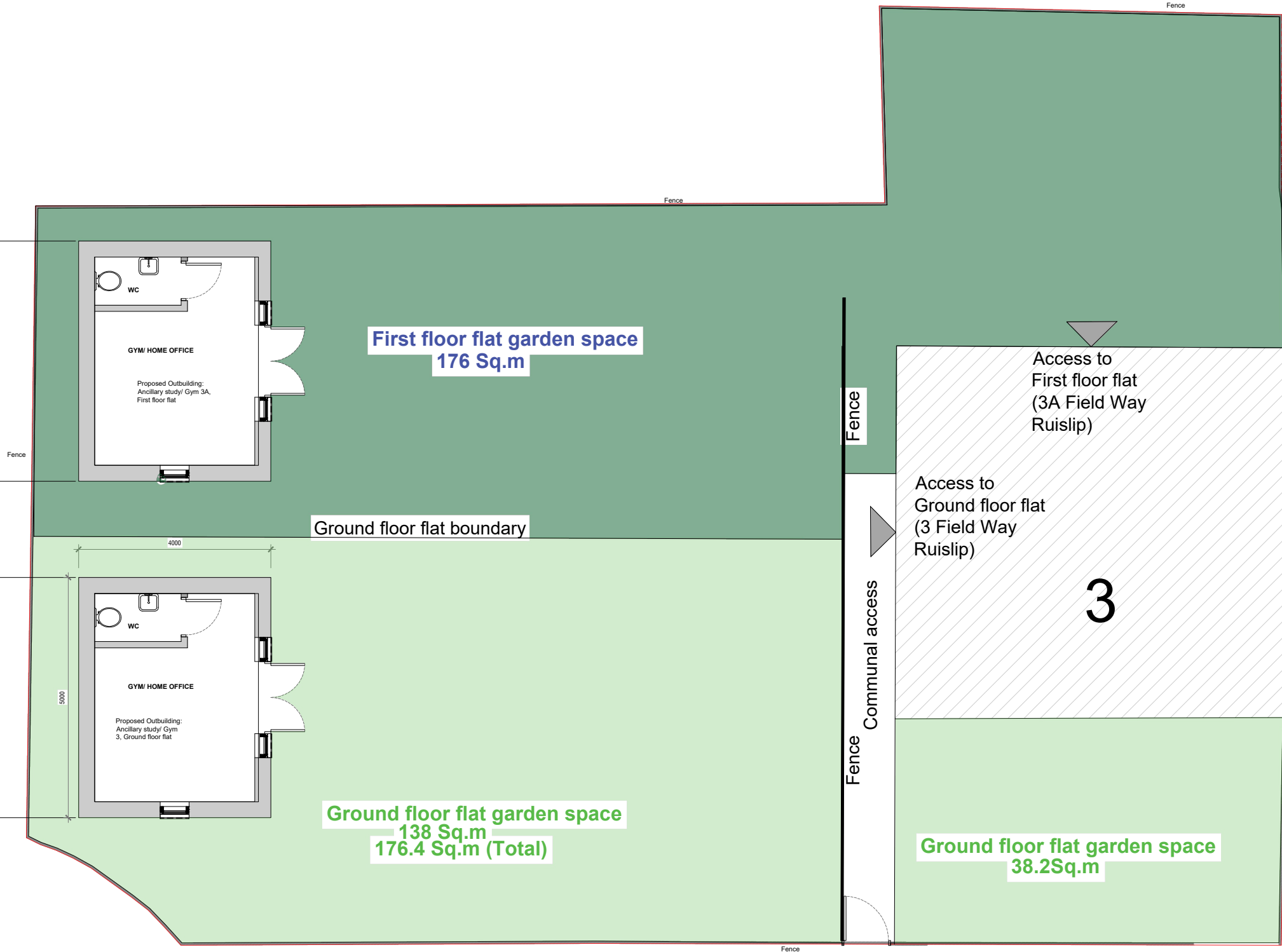

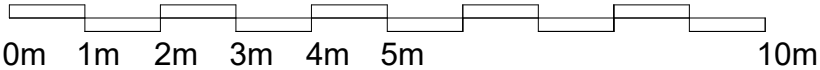

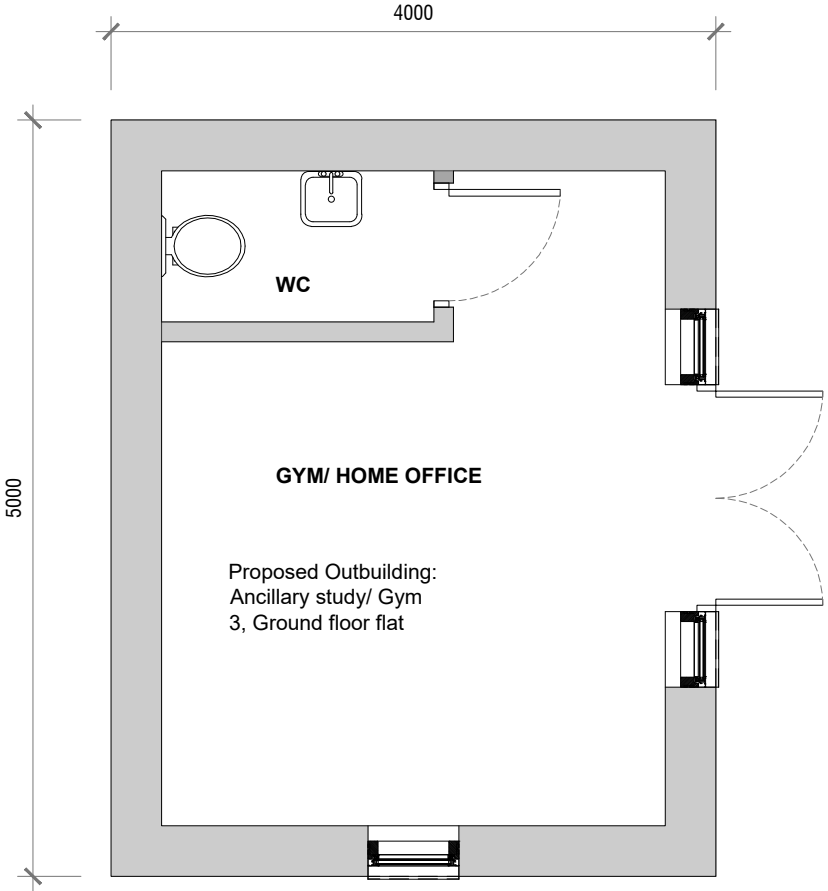

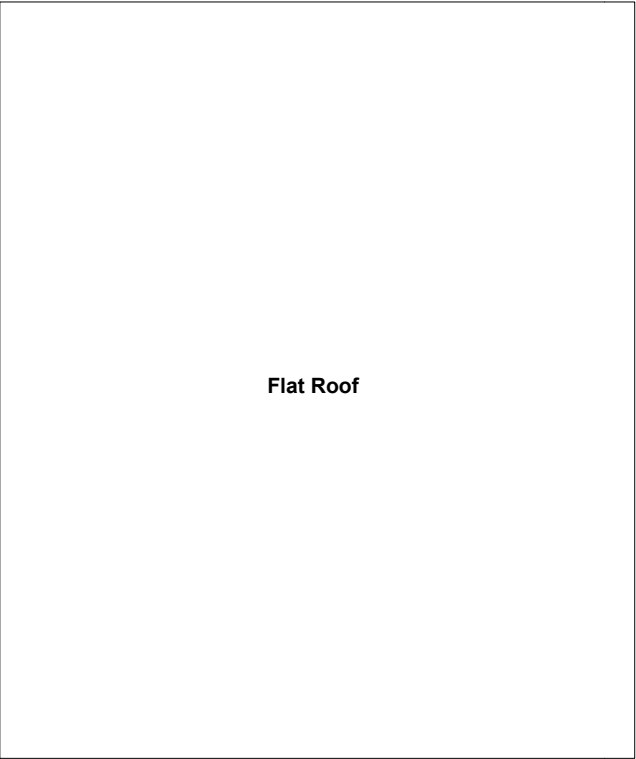

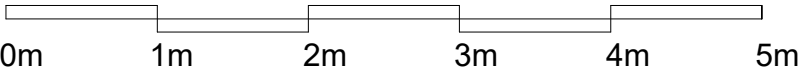


Proposed Outbuilding Plan

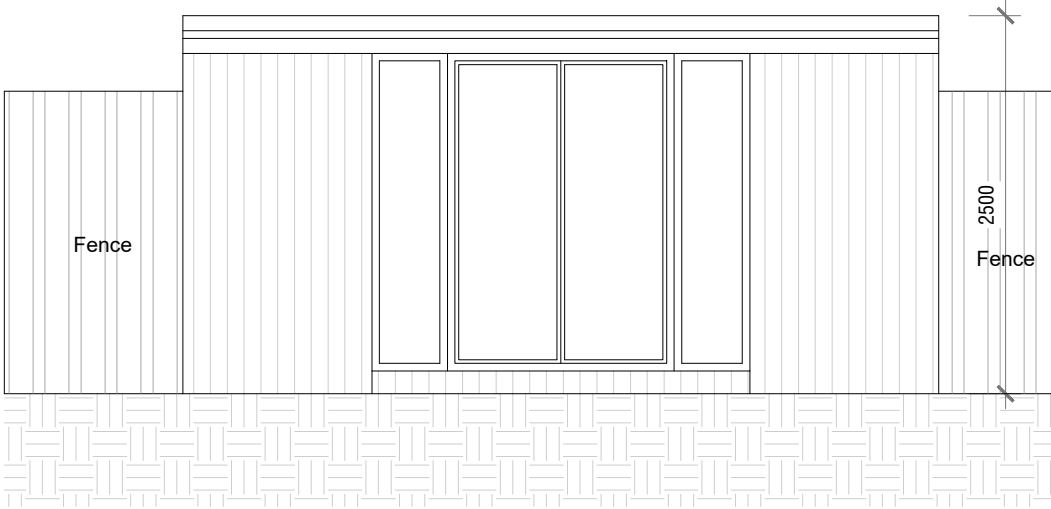

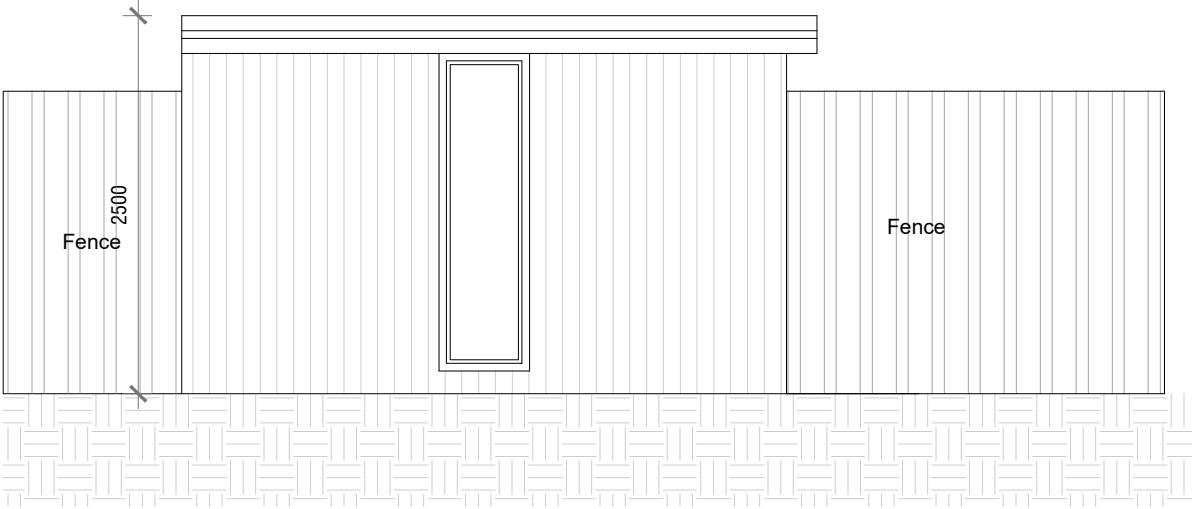

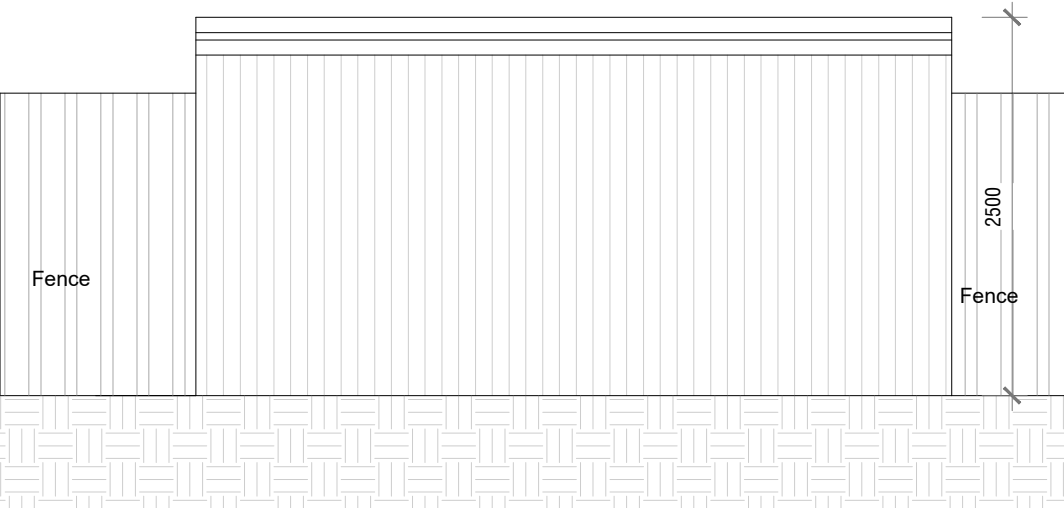
Proposed Outbuilding Front Elevation

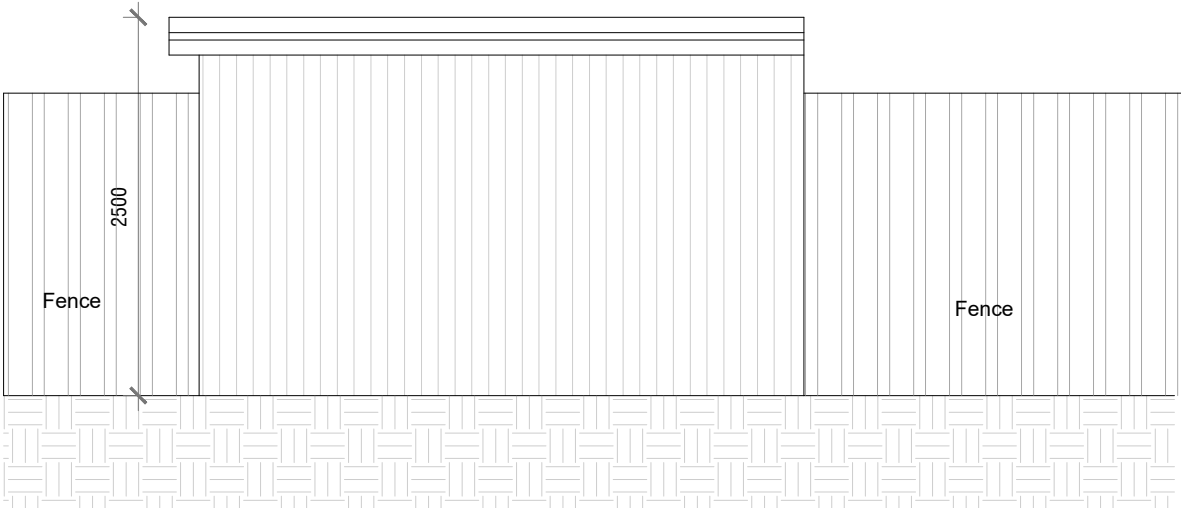
Proposed Outbuilding Left Side Elevation
