Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

Oak tree marked as T12 on the attached Plan.

The crown of the tree is irregular in shape as it is surrounded by large trees on one side. As a result, the branches extend to 8m over the garden and the garage but significantly less to the back. Work has not been carried out on the tree since prior to 2004, resulting in a need for the crown to be reduced to protect the health of the tree and re-instate the natural and balanced appearance of a typical oak tree. The application is for:

- Dead wood: removing major dead wood
- Crown shaping: reduce back overextended/splayed out growth into main crown profile on all sides as necessary to ensure balanced and natural crown form, whilst allowing for better wind resistance and appreciably reduce shading to the house and damage to drains on garage roof- Crown reduction: reducing the canopy by 1.5m to 2.0m
- Crown thinning: reducing the density of the tree's crown by 25% to 30% to allow more light into windows and to enable rainfall to reach grass and adjacent plants
- Maintenance: cutting new growth every 2 - 3 years

All work would be carried out in accordance with BS3998: 2010 Recommendations for Treework by a specialist contractor with adequate third party and public liability insurance.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
 - mark and name surrounding roads
 - sketch in buildings, including adjoining properties
 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
