Details of the pre-application advice received

The proposed development in its current form fails to provide an appropriate mix of uses that aligns with the aims of the site allocation policy. Whilst a retail use on the site could be supported in principle, it would be expected that this is provided in conjunction with residential and town centre uses that would contribute positively to the vitality of the North Hillingdon Local Centre. Furthermore the existing design of the building and surrounding spaces which are characteristic of a generic out of town retail store with extensive surface level car parking would not contribute positively to the character of the area and are not of a sufficiently high standard for an important strategic gateway site. On this basis officers recommend that both the design approach and mix of uses is entirely reconsidered and that the scheme is redesigned on the basis of the advice set out within this response.
