Details of the pre-application advice received

On 1 November 2022, the applicant, architect and planning officer Ms McMenamin met at the house at 237 Tolcarne Drive. The architect presented three options and the planning officer recommended to pursue the conservative option with the addition of two brick courses. The conservative option raises the ridge by the minimum amount required to make the loft habitable, the current loft being significantly too low for occupation. The addition of two brick courses is required to have sufficient headroom in the stair, as required by the Building Regulations. The planning officer recommended that we submit this revised scheme for planning approval.
