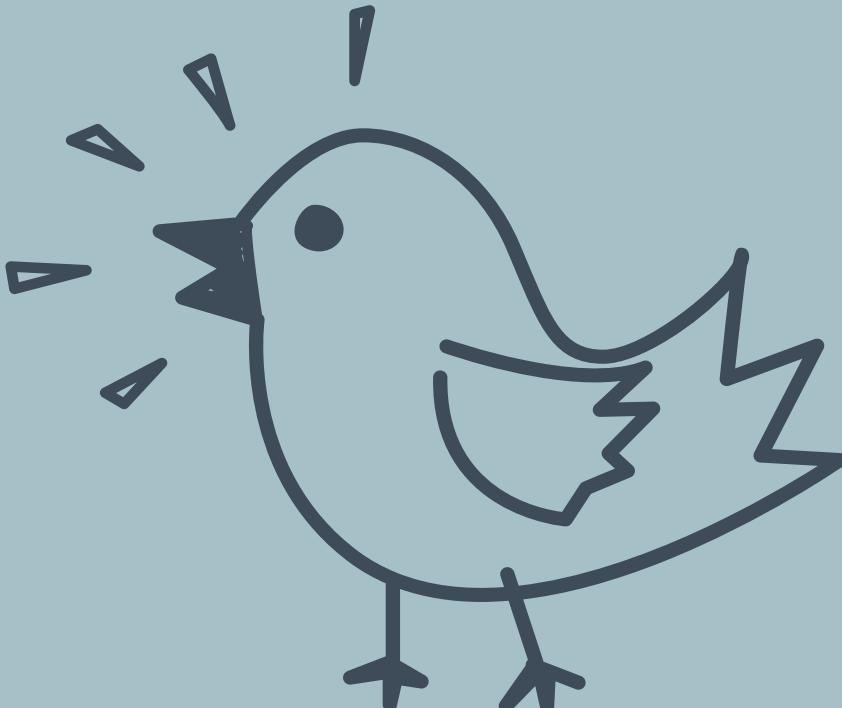

Proposal: Erection of single storey building at second floor terrace level within existing pergola to provide ancillary gym studio for residents, along with supporting condenser unit.
