Details of the pre-application advice received

In the first instance, the application site has an existing extension measuring 5.43 M deep on the Southern extent of the rear elevation, therefore the principle of such a deep extension on the site has been established. The proposed development would essentially be infilling the Northern extent of the rear elevation. Secondly the locality is dominated by large extensions, additions, outbuildings and gazebos which characterise the rear of the properties. Although dense, the extensions do not overly dominate the rear views due to the steep upward gradient and alignment of the plots. In addition, the proposed development, would have materials to match the existing house which would harmonise with the existing property.

Given the siting of the existing structure on the application site and neighbouring properties; it is considered that the proposed development would not confer any harmful impact upon the adjoining occupiers by reason of a material loss of outlook, loss of daylight, over-shadowing or over-dominance. The development is therefore considered to be in accordance with policies BE20 and BE21 of the Hillingdon Local Plan (November 2012)"

Considering the above, the proposed development is judged to have an acceptable impact upon the visual amenities of the application property, the character of the surrounding area and quality of the surrounding street scene, whilst no harmful impact would be conferred upon the occupiers of the adjoining or neighbouring properties by reason of a material loss of outlook, loss of daylight, over-shadowing or over-dominance.

The development is therefore considered to be acceptable in respect to Policy BE1 of the Hillingdon Local Plan: Part One - Strategic Policies (November 2012), Policies BE13, BE15, BE19, BE20, BE21, BE23 and BE24 of the Hillingdon Local Plan (November 2012) and the adopted supplementary planning document HDAS: Residential Extensions.

Accordingly, this application is recommended for approval.
