Work Required - reduce the limb over clients garden by removing around 2-3m

Reason -

Co-Dominant Leaders The tree has two major co-dominant leaders, one of which heavily overhangs the client's garden. This branch structure inherently creates a weaker point in the tree, increasing the risk of failure due to the lack of a central trunk and proper support between the leaders.

Excessive Extension Away from Main Canopy The overhanging leader extends significantly away from the main canopy, causing an imbalance in the tree's structure. This creates increased stress on the overextended leader and adds to the overall risk of branch failure.

Pruning to Reduce End Weight The proposed pruning aims to reduce the excessive end weight of the overextended leader. This will relieve the stress on the tree's structure, lowering the risk of failure.

Reduction of Wind Loading The extended branch, being exposed to wind from all directions, faces increased wind loading. Pruning will reduce the wind load on this portion of the tree, decreasing the chances of breakage during storms or high winds, and ensuring the safety of the garden and surrounding property.

Priority Code - B

Sketch plan requirements

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
 - mark and name surrounding roads
 - sketch in buildings, including adjoining properties
 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
