Work required- Reduce crown all round by removing approximately 2-3.5m to rebalance shape of tree, pruning to suitable growth points/branch fork junctions. Remove major deadwood over 25mm diameter and/or over 1m length. Remove branch growing towards neighbours house by pruning back to fork (approx. 5m off, See photo).
Reason - As per customers wishes, to form a more compact crown and reduce encroachment/debris over gardens
