No part of the hip to gable roof extension is higher than the existing ridge.
The materials will all match the existing finishes.
The velux roof lights will project no more than 150mm beyond the plane of the roof.
VOLUME OF ADDITIONAL ROOF SPACE
New Hip to Gable Extension = $\frac{1}{3} \times (0.5 \times 9.40 \times 3.40) \times 4.53 = 23$ cubic metres.
New Rear Dormer = $0.5 \times 3.54 \times 2.65 \times 5.25 = 25$ cubic metres.
