




2) Details of Hard Landscaping including refuse storage, cycle storage, means enclosure/boundary treatments, car parking layouts (including demonstration that two parking spaces are served by electrical charging points), hard surfacing materials, external Lighting and other structures (such as play equipment and furniture)

Attached, please find drawing 375-007-E showing the bin store / bicycle storage area (lockable) as well as EV charging points within the double garage (extra bicycle storage will be provided here too). I have also reattached the Rosebank scheme – and will send the remaining 3 drawings in the subsequent 2 emails for the material palette, permeable paving and planting scheme.

The information for the information below has already been sent- see landscaping plans – see highlighted requirement below. If you still feel there is information missing, please let me know and copy Manuel in to the email, please?

The location and types of ecological enhancement options for birds, insects and bats has just been sent to you.

"No development shall take place until a scheme to protect and enhance the nature conservation interest of the site has been submitted to and approved by the Local Planning Authority. Details shall include the control and removal of invasive non-native plant species, ongoing garden management and relevant best practice guidance, location and types of ecological enhancement options for birds, insects and bats, wildlife friendly planting, hedgehog doorways and an appropriate external lighting scheme to protect against harm to foraging bats".
