summary discussion points:

1) Principal of the conversion is acceptable.

2) concerns was raised that the first floor unit does not benefit from the amenity area. However, accepted that the property is close walking distance from the Stone field park & McGovern Park. Officer advised to state these park detail and approximate walking distance from the applicant site in the Design & Access Statement. This is now included in the attached statement.

3) Requested to submit the application once PD approval elements have been substantially completed.
