The application site was built in 1946 by the Hayes Spiritualist Society for church purposes and has been continuously used by them, categorized as F1 under the current use class. The building functioned as a spiritualist church until it was sold to the current owner. Learning, teaching, and training courses related to spiritual life, well-being, and religion were integral parts of the society's activities, offered to the community during the daytime, while evenings and weekends were reserved for church services.

Several documents supporting this use, including building insurance, land registry title, and a statutory declaration by the Spiritualist Society, have been submitted with this application. Additionally, the building is exempt from council and business rates as it is used as a place of worship and learning.

Given that the building was purpose-built as a church and has always been used by the Spiritualist Society, a Lawful Development Certificate should be granted.
