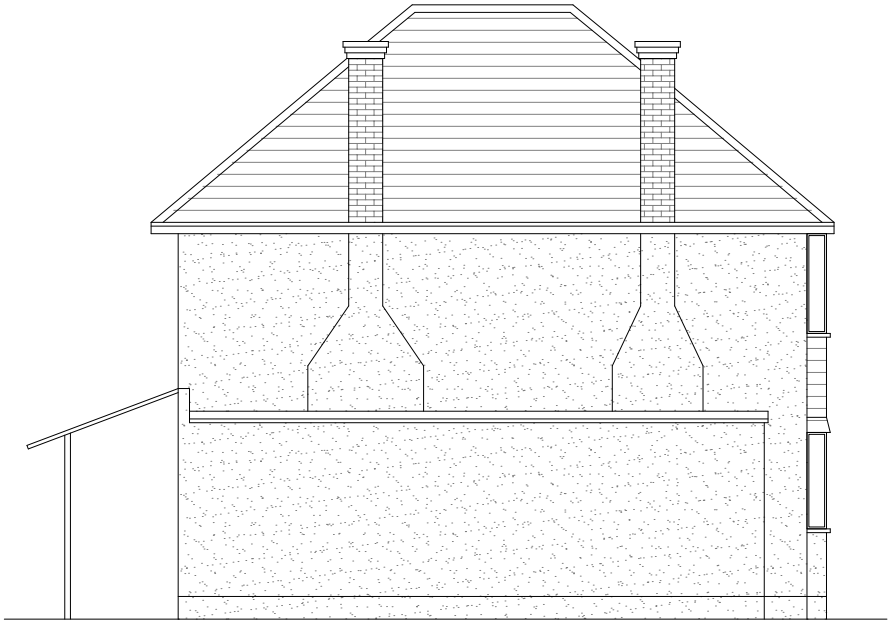
Existing Front Elevation

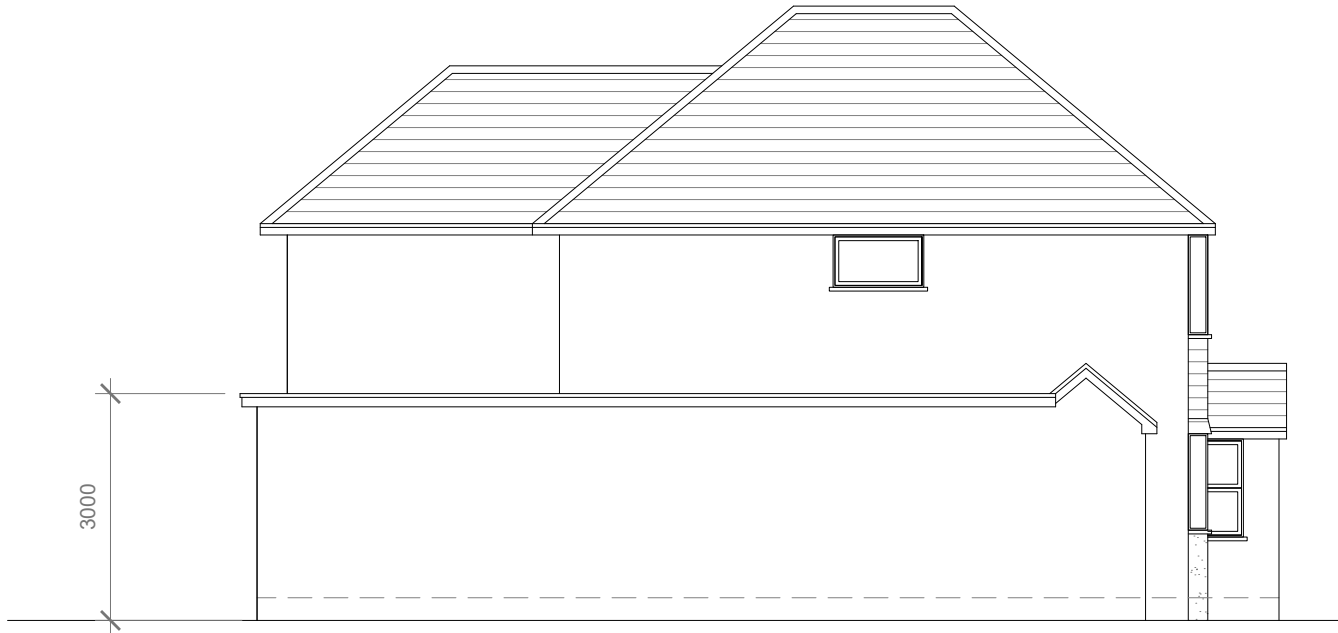
