Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

T1 - Cypress tree. removal of dead stem and 1-2m reduction to reduce branch end weight. Once the dead stem (IMG 1 and 2) has been removed we would like to reduce the tree as stated primarily focusing on the branches that are at a high risk of branch failure due to the length and weight of them, some of these branches can be specifically seen in (IMG 3) growing into the property. We would reduce the rest of the tree to match that. Including the over extended branches over the public path and road. We would hope that by reducing an already diseased tree we would reduced the risk of branch failure throughout the canopy.

T2-7 - Lime trees (IMG 4 and 5). Pollard. All trees have been previously pollarded. it has now been about 2-3 years since their last pollard. the growth is becoming to large for the pollard points. We suggest pollarding rather than a reduction due to the stems which have been previously 'monolithed', also to maintain the trees at a suitable size for the driveway. We have 5 limes trees within the property at 42 The Avenue, and 1 lime tree next door (44 The avenue) which we have been given permission by the owner to pollard. Although in different properties they all fall within the same TPO reference (TPO 685).

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
