23 Avonmore Road London W14 8RP 2025/01781/FUL

Deconversion of the existing building from 9no. self-contained flats into a single family dwellinghouse; erection of a three storey rear extension at lower ground, upper ground and first floor level, following the demolition of external steps in the rear garden and demolition of external staircase to the rear elevation at upper ground floor level leading into the rear garden; alterations to the main roof to include erection of metal railings around the flat roof in connection with the formation a roof terrace, and erection of a free standing sky box rooflight and glass balustrade provide access to the proposed roof terrace at main roof level; replacement of existing windows and doors with new double-glazed timber windows and doors to the front elevation; replacement of existing main front entrance door with a new timber door; alterations to the front garden to include, erection of a bike and a bin store with flat green roofs on top, formation of double access door to the front elevation to provide access to the proposed bike store; formation of a roof terrace on top of the flat roof of proposed three storey rear extension, enclosed in obscure glazing and timber privacy screening to both side elevations and metal railings to the rear elevation, and installation of double-glazed uPVC sliding doors with a toplight to provide access to the proposed roof terrace to the rear elevation at second floor level; replacement of existing windows with new double-glazed uPVC windows to the rear elevation; alterations to fenestration to include installation of new double-glazed uPVC double doors with a toplight following the removal of existing windows to the rear elevation between the lower and upper ground floor level; infilling of part of the rear garden and associated landscaping and alterations.

Replacement of existing single-glazed timber framed windows with double-glazed timber framed windows to the front elevation, and replacement of existing single-glazed critical metal framed window with new double-glazed uPVC window to the rear elevation at first floor level.

Clifford Haigh House 280 Fulham Palace Road London SW6 6HP 2025/01921/TPO

Fell to ground level of a Lime tree (T1) and an Ash tree (T2) located in the rear car park area, both subject to Tree Preservation Order TPO/27/11/70. Works to trees subject to Tree Preservation Order TPO/27/11/70 comprising of: pruning a London Plane Tree (T3) in the rear car park area, by removal of epicormic growth; pruning of a Lime tree (T4) by the entrance to car park on Crabtree Lane, by reduction all round to previous reduction points approx. 2-3m and removal of dead wood; pruning of an Ash tree (T5) on the Crabtree Lane frontage, by reduction back from property to give 2m clearance and lift over pavement to statutory height; pruning of a False Acacia tree (T6) on the Crabtree Lane frontage, by reduction all round to previous reduction points approx. 2m; pruning of a Lime tree (T7) on the Crabtree Lane frontage, by repairing cavity at approx 1m and creating new pollarded form at approx. 4m above ground level (3-4m reduction); pruning of a Lime tree (T8) on the Crabtree Lane frontage, by reduction to give 2m clearance from property and lift over pavement to statutory height; pruning of a London Plane tree (T9) on the Crabtree Lane frontage, by repollarding by approx. 6-7m; pruning of a London Plane tree (T10) on the Crabtree Lane frontage, by repollarding by approx. 6-7m; pruning of a Lime tree (T11) on the Crabtree Lane frontage, by reduction all round to previous reduction points approx. 2-3m; pruning of a London Plane tree (T12) on the Crabtree Lane frontage, by reduction all round to previous reduction points approx 2-3m; pruning of a Lime tree (T13) on the Fulham Palace Road frontage, by reduction all round to previous reduction points approx 2m; pruning of a London Plane tree (T14) on the Fulham Palace Road frontage, by lifting over road, pavement and bus shelter to statutory height; and pruning of a Lime tree (T15) on the Fulham Palace Road frontage, by reduction all round to previous reduction points approx 2m.

21 Eustace Road London SW6 1JB 2025/01793/FUL

Erection of an additional floor at main roof level; erection of a single storey rear extension to the rear of the existing back addition at lower ground floor level.

57 - 59 And 61 - 64 Fulham Park Gardens London SW6 4LB 2025/01799/FUL

Erection of single storey rear extensions to the side of the existing back additions including the installation of new doors and window openings to replace the existing at ground floor level to the rear elevation; excavation of the front and rear gardens to form lightwells in connection with the enlargement of the existing basement; conversion of ground floor of no. 61 Fulham Park Gardens from 1 x 3 bedroom self-contained flat into 2 x 2 bedroom self-contained flats; erection of bin and cycle stores at the front of the building.
