Details of the pre-application advice received

The proposal included a side extension and over 6 persons. Therefore, the development was not supported. It is noted in a follow-up call with Nurgul Kinli however, that if we are to reduce the number of occupants down to 6 and provide clarity on access, then the development is likely to be supported.

The conclusion of the pre-application advice states:

Given the points raised above, it has been suggested that the agent and applicant consider applying for a Certificate of Lawfulness for the conversion of the dwelling from C3 to C4. The agent and applicant have also been advised that in this instance no more than 6 occupants could lawfully reside at the property and the studio flat would need to be removed.
