The proposed development includes the construction of a 48m² concrete base for a small-scale commercial structure. However, this will incorporate an existing 25m² hard standing already in situ. These surfaces currently have negligible biodiversity value. As a result, the total area of potential biodiversity loss is limited to low-value garden substrate. This falls below the threshold of 25m² of habitat impact commonly referenced for BNG exemptions and qualifies as de minimis under Natural England's BNG guidance. The proposal will not result in the loss of priority habitats or ecologically valuable features. Therefore, it is requested that this development be considered exempt from the requirement to provide a formal Biodiversity Net Gain assessment.
