Proposal Features:

- 3m<sup>2</sup> Porch under 3m in height from existing ground level and finished with matching materials to the existing facade as per permitted development requirements.
- Proposed loft conversion incorporating a hip to gable and rear dormer expands the current loft space by 48m<sup>3</sup> (under 50m<sup>3</sup>) and is set back 200mm from the existing roof eaves. The dormer will be finished with tiles matching the existing roof and a continuation of brick and render at it's gable end, to conform with as per permitted development requirements.
